- 1. \$200 deposit (\$2,000 for weekend tournaments) is required within 15 days of tournament date.
- 2. Tanglewood must receive **final** confirmation of the total number of players and meals at least 72 hours before event date. This is the minimum number that the tournament director will be responsible to pay for.
- 3. If contract and deposit are not received within time frame, tournament reservation will be cancelled.
- 4. Cancellation Refund Policy:

90 days or more......100% Refund of Deposit 31-89 days notice.....50% Refund of Deposit 30 days or less.....No Refund of Deposit

- 5. Deposit is 100% refundable if there is an official course closure and tournament can not be rescheduled.
- 6. All monies owed to Tanglewood are due at the conclusion of the event.
- 7. Please- NO outside alcohol, as per Missouri State liquor laws.
- 8. Tournament will be invoiced for total number of meals established in contract.
- 9. Hole in One Information: Hole in One Insurance Companies will accept the yardage for hole in one holes as shown on this contract. We ask that you do not exceed the yardages shown. It is important that the individual responsible for your tournament's hole in one information, fax a copy of the hole in one insurance contract at least one week prior to the tournament. If we do not receive a hole in one contract, we can not guarantee proper setting of the tee markers, nor can we certify to the insurance company that the hole was properly set in the event a hole in one is made. Please fax copies to (573) 642-6673
- 11. You must provide your own witness for the Hole in One hole(s).
- 12. Courtesy Cart Two courtesy carts will be available for use by your tournament volunteers.
- 13. Speed of Play -- 18 holes of golf should be played in 4 1/2 hours or less. Please ensure that players are aware of the need for prompt speed of play. Tournament Marshals have the authority to ask slower groups to move more quickly or allow faster groups to pass.
- 14. Appropriate golf attire is required for all players. Soft spikes are required for all players.
- 15. The Tournament Director agrees to be responsible for all golf carts and any and all damages to golf carts.
- 16. Course Management reserves the right to remove any player in violation of course policies with no refund.
- 17. If more than 60 carts are requested, tournament will be charged \$35 for every cart over 60 that is *not used*.
